In the Government Order third read above, among others orders were issued to redesignate the posts of Inspectorate of Factories and in the Government Order fourth read above, an enforcement machinery was created for effective enforcement of the provisions of the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 and the Tamil Nadu Building and other Construction Workers (Regulation of Employment and conditions of Service) Rules, 2006 in the office of the Director of Industrial Safety and Health with certain posts for the Directorate of Industrial Safety and Health.
